Please use the official social media accounts ("Our Official Account(s)") provided by Nippon Yusen Kabushiki Kaisha, NYK, or NYK Line (the "Company" or "us") only after agreeing to the following Terms ("Terms"). By using Our Official Accounts, you are deemed to have accepted these Terms.

### **Article 1: Operation**

Our Official Accounts, provided by the Company, are operated by the Company. The operation of Our Official Accounts may be terminated, or the content within Our Official Accounts may be deleted without prior notice. Additionally, The Company may not respond to all comments and inquiries posted on Our Official Accounts.

### **Article 2: Scope of Application**

These Terms apply to all Users of Our Official Accounts ("User(s)"), including those who access Our Official Accounts for viewing purposes only.

### **Article 3: Changes to These Terms**

The Company may change these Terms without obtaining the consent of Users. The revised Terms will become effective at the time they are posted on the Company's website or otherwise made public, and Users will be subject to the revised Terms thereafter.

### **Article 4: Prohibited Actions**

Users are prohibited from engaging in the following actions when using Our Official Accounts. Comments that fall under these categories may be deleted, accounts may be blocked, and legal measures may be taken.

1. Actions that infringe or may infringe on the rights and interests of the Company, other Users, or third parties.
2. Actions that defame the Company, other Users, or third parties, or defame their services, etc.
3. Political activities, election campaigns, or similar activities.
4. Proselytizing or soliciting for specific religions, organizations, or groups.
5. Using information obtained from Our Official Accounts for commercial purposes.
6. Actions that disadvantage the Company, Users of Our Official Accounts, or third parties.
7. Actions that obstruct the operation of Our Official Accounts or damage the reputation of the Company.
8. Posting or transmitting harmful computer programs, etc.
9. Impersonation or the Company providing false information about others.
10. Actions that violate the Terms of various SNS platforms, public order and morals, or laws and regulations.
11. Other actions that the Company deems inappropriate.

If a User's actions cause damage to the Company, the Company may claim compensation for the damage from the User. If a User causes damage to a third party by using Our Official Accounts, the User shall resolve the matter at their own responsibility and expense.

### **Article 5: Disclaimer**

1. The Company does not guarantee the accuracy, safety, or appropriateness of the information posted on Our Official Accounts. The Company assumes no responsibility for any damage, loss, or disadvantage incurred by Users as a result of using the information posted on Our Official Accounts.
2. Our Official Accounts use the services of external companies. The Company cannot respond to inquiries about the usage, system operation, provided functions, or safety of these external services. Similarly, the

Company cannot respond to technical questions about software or applications provided by third parties.

3. The Company assumes no responsibility for the accuracy or legality of the information posted on Our Official Accounts by Users or third parties. The content posted does not represent the Company's views or positions.

4. While copyrights to posted information generally belong to the User who posted it, by posting, Users grant the Company a non-exclusive, worldwide, royalty-free right to use (including processing, excerpting, copying, publishing, translating, etc.) the posted content. Users also agree not to exercise their moral rights against the Company.

#### Article 6: Copyrights and Trademarks

These Terms are governed by Japanese law. In the event of a dispute between Users and the Company, the Tokyo District Court shall have exclusive jurisdiction as the court of first instance.
